Motion re: LSB Vacancy (Rajat Chopra) (Approved, Aug 2025 meeting)

Whereas Revised Pacifica Bylaws for Pacifica v. New Day Pacifica et al. Settlement (2025), Article Four, Section 5, (C) stipulates that "any LSB Member shall be removed from the LSB and cause to hold an LSB position upon the occurrence of any of the following:

(C) Failure of an LSB Member to attend three consecutive LSB meetings, which absences have not been excused by a majority vote of the LSB member present at the meetings in question;"

Whereas Rajat Chopra has missed three or more consecutive unexcused LSB meetings and is no longer eligible to serve on the LSB;

Whereas, Section 6: Filling of Vacancies provides: "If an LSB Officer or Other LSB Member or LSB Staff Representative position becomes vacant mid-term, the LSB shall elect a replacement for the remainder ot the three-year term from among the members of the same station and class;

Therefore, the KPFT LSB will initiate the procedure to fill the unexpired term of this listener member, Rajat Chopra, as follows:

The election to this position will be announced at the KPFT LSB meeting of August 13, 2025, posted on the KPFT Web Site and the KPFT Facebook page following the meeting and will be announced on air, with a deadline of candidate submissions to the KPFT LSB Secretary no later than midnight CT, Friday, September 5, 2025 who will then forward them to all LSB members;

Candidates will be invited to make statements at the KPFT LSB meeting on September 10, 2025;

The election will be held by OpaVote with ballots issued on September 12, 2025 and due by midnight CT September 26, 2025, which deadline can be extended if quorum is not reached and results announced as soon as possible after the deadline;
