Whereas the Pacifica Network is once again in a desperate financial crisis that threatens its continued existence,

Be it resolved that the PNB orders the general managers at all five stations to submit as soon as possible but no later than August 15th, data as to the most recent subscriber responses to programing, specifically every program in every time slot shall provide garnered or committed sum-total subscriber contributions toward the operating expenses of the network promised or delivered to the station for that program and time slot.

Additionally, for each program and time slot that offers premiums, the cost of acquiring all such premiums including the cost of delivering such premiums shall also be provided.
