Motion Establishing One Bank for Pacifica's Banking Needs

Whereas Pacifica expends scarce resources in the wiring and transfer of funds between units at least twice a month for routine purposes such as for payroll and the payment of health insurance,

And whereas, Pacifica could also benefit from having one bank provide all its banking needs by obtaining higher levels of free transactions per account,

Therefore be it resolved that the Executive Director and National Business Manager are authorized to establish bank accounts for each unit at one bank beginning with the new fiscal year, starting on October 1, 2023; and

And be it further resolved that each unit will have its own account at this bank, with national office staff having the ability to view transactions and account balances. The Pacifica National Office will also perform bank reconciliation each month.

APPENDIX

6. Report from Ad Hoc Committee on Eric Jacobsen motion from July 20, 2023 Motion passed at July 20, 2023 meeting (in executive session)

Whereas KPFK Delegate Eric C. Jacobson, KPFK representative on the national Elections Committee, was wrongly removed from the Committee roster and excluded from a Committee meeting at the direction of KPFK Secretary Pro Tem Kim Kaufman, on the basis that he was supposedly no longer a Delegate, which he contests; and

Whereas Mr. Jacobson was subsequently restored to his seat on the Elections Committee upon the intervention of Pacifica General Counsel; and

Whereas Mr. Jacobson, elected by KPFK Listeners to represent them on the KPFK Local Station Board, was wrongly removed from the LSB roster and excluded from an LSB meeting on the basis of the assertion of KPFK then-Secretary Pro Tem Kim Kaufman, Chair Harvey Wasserman and others, that he is supposedly no longer a Delegate, which he contests; and

Whereas Mr. Jacobson was provided neither warning, nor notice, nor opportunity to appeal the ruling locally, nor any other measure of due process, and was referred by the KPFK LSB Chair to the PNB for resolution of the matter; and

Whereas elections to replace Mr. Jacobson on the national Elections Committee and to fill other national committee seats have since begun and are now underway, excluding him and denying him participation as a candidate or nominator, or as a voter; and

Whereas such charges would be serious at any time, they are particularly so during Pacifica's long delayed national elections, with an elected seat on the national Elections Committee in question, with Pacifica's elections practices already under the scrutiny of the Court, and with Pacifica having been warned to adhere to the bylaws throughout;

Therefore be it resolved that the PNB shall schedule an executive session at a time to be determined, but no later than August 10, 2023, to hear and resolve the matter.

Be it further resolved that in it's [sic] duties of care, compliance, and fidelity, and to minimize the risk of further liability, the PNB hereby suspends the KPFK LSB elections to national committees, currently underway, until Mr. Jacobson's status as a Delegate is resolved and the correct KPFK roster is verified.

7. Determining Whether Newly Elected Delegates begin in November or December Motion passed at August 17, 2023 PNB meeting (open session)

Whereas there were insufficient funds to hold elections in 2022, which was year 2 of Pacifica's 3-year election cycle in which half of the delegates would be elected;

Whereas the PNB passed a motion on October 20, 2022 providing that delegates whose terms would have ended in 2022 would continue to serve in 2023 if Pacifica failed to hold elections;

Whereas delegates whose terms would have ended in 2022 were either in their first term and therefore eligible to run again, or in their second term and therefore ineligible to run again, according to the Pacifica bylaws, and the delay from 2022 to 2023 in holding elections does not change that eligibility status;

Whereas Pacifica is in the midst of the election cycle for 2023, with the record period having passed, the period for candidate nomination having closed, the ballots not yet sent to members, and ballots slated to be sent to voters in the second half of August; and

Whereas it is important for voters to understand before they cast their votes the length of terms to which successful candidates would be elected and serve;

Therefore, be it resolved that all candidates running in the 2023 delegate elections are running for two-year terms, and that the elections.pacifica.org website shall reflect this information. Pacifica elections would return to the Article Four, Section 3 schedule of holding elections in years one and two and no elections in year three (i.e., elections in 2024 and 2025 but not in 2026).

Management will routinely monitor emails sent to <u>concerns@pacifica.org</u> and ensure that the appropriate actions are taken. Concerns about Pacifica policy can be sent to the LSB (insert station's LSB email) or to the PNB (<u>pnb@pacifica.org</u>) as appropriate. Delegates serve as volunteers and will take up your concerns as time and priorities permit.
