PNB Director's Report to Listeners and the KPFK LSB October 1, 2023 Beth von Gunten, PNB Director

Finances, the just-completed Delegates Elections, the continuing attempts to sell the KPFK property, and other matters are covered elsewhere by other, so this report will focus on the PNB Investigative Committee looking into the challenge to the KPFK LSB roster.

The PNB Chair recently expanded the Committee, appointing KPFK Director Ali Lexa Alhilali and myself in hopes of accelerating the work. The Committee met Friday, is scheduled yo meet again tomorrow, hopes to meet again later this week, and will report at this Thursday's PNB meeting.

For purposes of that investigation, at the August 20, 2023 LSB meeting I requested a copy of the current KPFK LSB roster of members and attendance for the year to date, with all changes to the roster listed, with an explanation of each change.

I have since requested that information twice more in writing. The LPFK LSB Officers have so far failed to verify, validate, or to respond with any information at all regarding the roster.

Therefore, still seeking this basic statement of information from the Officers, today I reiterate my request, this time as a formal Directors Inspection. The PNB awaits their response.

By comparison, the same request put to the other faction of this painfully split LSB on the same date resulted in their Secretary John P. Garry providing a complete annotated roster spreadsheet within 12 hours flat, no excuses, no delay. Many thanks to Mr. Garry for his prompt, courteous, orderly, and complete response.
