# Jerry Paris, General Manager stated,

The PPP loans paid the last WPFW payroll. The rent and health service were paid. Next month WPFW will begin paying salaries. The transmitter is doing great.

Arthur, chair of LSB stated Katea addressed some allegations that were made about her at the last Program Committee meeting inclusive of decreasing Jazz programming at the station, of which she clearly expressed/characterized all counts to be non-factual. ### Questions and Statements for the PD:

Vanessa asked:

How are programming decisions made?

Katea (PD) stated that programming decisions are made by the PD in conjunction with the GM.

Vanessa stated, you provided some data as to the total number of hours of jazz programming (per week) as compared to the number of hours of other types of programming. Jazz is by far the primary type of programming. See Attachment C the Program Director detailed information about programming at WPFW.

Vanessa stated, you discussed that wpfw programs are so successful that they are being "borrowed" by other Pacifica stations in order to increase their listenership.

Vanessa stated, you also talked about some new programming -- e.g., the women's collective - Meeting in the Ladies Room - that replaced the jazz show formerly hosted by Craig Hall. You may have mentioned - but I don't recall - that this spot - Friday's at 10PM - was previously occupied by a program hosted by a woman Page **2** of **10** 

(Keanna Faircloth) and you informed Craig more than a year in advance that his jazz show would be replaced by another woman-hosted show. I noted that the new program, which features House music, also includes jazz.

Eileen asked, Can you provide a written report?

Katea said that they are understaffed and she is working on many pressing issues; consequently, she is unable to provide a written report.

# VI. Finance Committee Report (submitted a written report: See Attachment A)

Nick Arena stated,

The winter drive was successful. We had \$2000 in the bank at the end of March. We made 4 payments to Central Service. We are still talking with major donors.

Questions:

Lou wants an accounting of the anonymous donors. Ron said we can't divulge that kind of information.

Julie stated that the station has a budget deficit in income; however, we are receiving a major donation that cancels the deficit.

Martha Peterson requested an update on the meeting the GM had with Jerome Page. Jerry (GM) said he had an initial conversation with Jerome Page.

Thomas O'Rourke asked are we caught up with Central Service payments. Jerry (GM) said, we are still making payments for 2019 and 2020.

# **VII.** Community Comment

Cliff Smith asked,

- 1. What is the status of the HD project at the station? Jerry (GM) stated that the HD project was tied to the new transmitter project that will lead to the HD project completion. It should take about 90 days. There is still a lot of work to be done.
- 2. Are we paying off the WBAI loan principal? Jerry (GM) stated WPFW and others are paying interest on the loan.

Community person stated,

It is not a WBAI loan it is a Pacifica loan. She discussed the New Day bylaws.

Mrs. Cooper

Spoke about the police killing of her son, 24-year-old Kwamena Ocran. She asked for help with publicizing the occurrence. Ron said he would discuss it during his program on Friday.

# VIII. PNB Report

Ron

PNB is meeting weekly.

<u>Julie</u>

We received an extension on the \$3 million loan. Two PPP loans were received and one loan became a grant. We are on target to receive the 2<sup>nd</sup> PPP loan. It may turn into a grant.

### <u>Eileen</u>

The 2019 audit should be completed by April 30. She has scheduled a meeting to review the audit and then she will send it to the PNB. NETA accountants said by June 20th they could complete the 2020 audit.

### Vanessa

No reports for Governance and Personnel Committees.

### IX. Outreach and Development (submitted a written report: See Attachment B)

Martha Peterson stated,

The Virtual Walk is in the planning stages. It will occur on June, July or August. The price will be \$30 with Certificate of Completion or \$45 which includes a T-Shirt & Certificate of Completion to participate. The Town Hall will occur on May 7th or 8th from 5pm to 7pm. The Town Hall is virtual and will be broadcast from WPFW. Timekeepers are needed for the Town Hall.

### X. Programming Committee

Interim Chair, Craig Hall stated,

Sabooh Hikim is chair of LSB show. The Programmers Bill and Evaluations were discussed again during the meeting. There was a discussion about programming standards. **The LSB show** on April 23 will cover the police killing of Mrs. Cooper's son in Gaithersburg, MD.

Motion: The WPFW Local Station Board votes not to support the NEW Day referendum.

There was no objection to the motion. The motion was approved.

The evaluation will consist of a mid-year review/report due in April and an EOY evaluation/report due in Oct. The draft of this evaluation criteria shall be discussed and approved by the LSB, the GM and PD together!

### **Financial Budget**

1. A vote on a \$50 per annum for LSB personal budget as needed for Zoom, gifts, fundraising, etc. [Due at June the meeting}—that's equivalent to \$12.50 per month for this first implementation if started in March. If it continues in the years hereafter it will be \$10 per month starting in February of each year. Lump sums are acceptable due by June. Explanation and deep discussion is merited for this item due to member and station restraints.

- b. He also wants the CSE Committee to evaluate each LSB meeting.

### Attachment A

WPFW Finance Committee Report - Monday, April 5, 2021

1. Station Cash Flow Update: Bank Balances were \$207K as of March 31. This is due to the Winter Pledge Drive raising over \$368K (122% of goal). Congratulations and thanks to all the staff, programmers and volunteers. Additional major donor gifts are expected in April thru June. Off-air and other types of fundraising are still needed due to shortfalls in 2019 and 2020. Certain LSB members and the General Manager will be discussing new grant opportunities and foundation going forward.

2. 2021 Budget Revenue and Expense Updates: Financial statements are being provided by NETA, the interim CFO to Pacifica who also is providing accounting support to the Station. November statements were available at the time of the report.

PNO estimates that WPFW past due Central Services payments for FY19-20 are approximately \$170K. Additional payments for other expenses from FY19 are estimated at \$100K. The PPP loan funds received by the PNO has allowed the Station to make 4 PNO Central Services payments and PRA Central Services payments totaling \$73K in March. This is the major reason that Actual Expenses were \$44K higher than Budget in March. Three large major donor contributions budgeted for November, December and January are now expected April thru June. In addition, a large portion of the Winter Pledge Drive will show up as revenue in March versus February. Lastly, this is the main reason for shortfall in the Estimated Actual FY2021 Budget to Actual provided below:
