WPFW JAZZ AND JUSTICE FESTIVAL IN COLLABORATION WITH PARKS AND PEOPLE

Producing event which includes helping to book artists; working with budget, working with volunteers to create activations throughout the park; securing stage, sound, backline and tents; overseeing general execution of festival. The festival runs noon-8pm, Sunday, June 22. If interested in working with any of the following activations – Elders Circle/Telling Our Stories; Children's Circle; Liberatory Justice Circle; Labor Circle; Wellness Circle – please contact me.

COMMUNITY WATCH & COMMENT RESPONSE

Community Watch and Comment, airing 11am until noon, began almost 20 years ago as a strip devoted to call-ins. Over the years, the quality of this only call-in programming suffered due to the number of diverse callers. We're often left with the same callers several times a day and to new listeners it has been said to sound like a club, which isn't good for welcoming in new listeners, and by extension, donors.

As of now, the Tuesday and Friday shows offer consistent opportunities for call-ins. We also have several programs throughout the grid that open the phone lines, so callers are not incorporated into or limited to Community Watch and Comment only.

We are working to fill 11am Mondays. Wednesdays is David Whettstone, who does open the phones on occasion. Thursdays is syndicated programming - Code Pink.

There is no formula for caller times/numbers/engagement, but most programs except for the syndicated ones include callers at least once a month.

SOCIAL MEDIA INITIATIVE

We continue to work closely with Kwadjo to primarily brand WPFW by telling our story, both historical and contemporary; highlighting regular and special programming; and educating on what listener-supported radio and WPFW are, their significance, and how to support us through compelling visual and video content. Please check out and share our Instagram profile – WPFWDC. By doing this, you'll be helping grow WPFW! We utilized the IG campaign to amplify our James Brown special, which got significant engagement, and will utilize it for Radio Free Palestine and Malcolm X centennial programming. We also used Mariah video promoting upcoming LSB Town Hall as a reel on IG, and it too enjoyed significant engagement; finally, Kwadjo has created a series of reels (videos) titled Moments in Jazz and Justice featuring iconic Jazz musicians speaking about, or performing a piece that spoke to social justice. They are wonderful. Look out to them.

OUR ANCESTORS' WILDEST DREAMS: JUNETEENTH IN THE AGE OF ERASURE – JUNE 19

Working with Thomas Blanton and Thursday Programmers to create a special day of programming, which we've presented for over a decade now.

THE HOUSE THAN WANDA BUILT – JUNE 30

As we've done for over a decade, we dedicate our commemoration of Pride month to Beloved DC gay activist, Wanda Alston, a fierce advocate of housing programs for homeless and at-risk LGBTQ youth.

On Monday, June 30, WPFW will present *The House That Wanda Built 2025*, our Pride special Programming. From 9am until midnight, we'll broadcast voices, discuss issues, and present music honoring the life and legacy of Wanda Alston and all our LGBTQIA+ family.!

PAST SPECIAL PROGRAMMING:

REVOLUTION OF THE MIND: UNPACKING THE GENIUS AND TORMENT OF JAMES BROWN – MAY 3

We began our Spring Pledge Drive on May 3, with honoring the birthdate of James Joseph Brown, suggested by Programmer Scooter Magruder. The contributions of all the Programmers were stellar - presenting his music, delving into his complicated and tumultuous family history and sometimes troubling behavior, and celebrating his artistic and entrepreneurial legacy and his activism. Brown believed in Black economic empowerment as a pathway to Black liberation. All of this was highlighted and made for an extremely strong financial start to the pledge drive.

BLACK SHINING PRINCE: MALCOM X AT 100

We closed our Spring Pledge Drive on May 19 by celebrating and unpacking the life and legacy of one of the most brilliant and charismatic intellectuals and Pan-Africanists of the 20th Century on his centennial. The teachings, speeches and writings of el-Hajj Malik el-Shabazz continue to impact, inform, and guide millions around the world in their quest for liberation. The title is a reference to Ossie Davis' eulogy of Malcolm X where he referred to him as "our own Black shining prince." We offered a WPFW curated Malcolm Lives and our Black Shining Prince programming on June 19 as downloadable gifts exclusively available only on that day.

RADIO FREE PALESTINE – 77TH ANNIVERSARY OF THE NAKBA

Thursday May 15th marked the 77th anniversary of the ongoing Palestinian Nakba, or catastrophe, and the people's resistance. Radio Free Palestine is special programming marking this day and ran from 8am until 7pm on WPFW and stations across North America to air programming from radio stations and producers across 5 continents. There were separate streams in Arabic, English, French and Spanish. WPFW produced the English stream for Radio Free Palestine, and included discussions, speeches, music, poetry and updates on the ongoing genocide and resistance. Content was contributed by a number of WPFW Programmers, Brigade member Cody Valentine, Palestinian Youth Movement DC, and Producers from CKDU (Halifax, Nova Scotia); KBOO (Portland, Oregon), both of which are also carried it along with CFRC (Kingston, Ontario). WBAI also carried broadcast segments.

WPFW became the Executive Producer of the English language stream when Founder and Producer, Laith Marouf who worked with the Canadian stations before having to return to his

home country of Lebanon after October 2023, where his family still lives. Because of WPFW's contribution of both content and carriage for several years, he asked if I/we would take the lead to ensure the continuation of the English language stream since he was no longer to carry it from Lebanon. He is an excellent and well-respected journalist, and like so many in Lebanon, has been having an increasingly difficult time due to the Israeli governments bombing of the country. This year's program is especially poignant given the utter and unrelenting devastation and decimation of the Palestinian people we've witnessed over 17 months. This special is dedicated to the resilient spirit of Laith, and the Palestinian people.
