PROGRAM DIRECTOR REPORT JULY 2025

In addition to regular PD duties, the projects listed below reflect a summary of my work:

WPFW JAZZ AND JUSTICE FESTIVAL IN COLLABORATION WITH PARKS AND PEOPLE

We successfully produced WPFW's inaugural Jazz and Justice Festival which included helping to book artists; working with budget, working with volunteers to create activations throughout the park; securing stage, sound, backline and tents; overseeing general execution of festival. The festival ran noon-8pm, on Sunday, June 22. In addition to the main stage, we presented wraparound activations including the Elders Circle produced by WPFW's Brigade group; Children's Circle produced by Johanna Stitt-Abow; the Labor and Wellness Circles produced by Joni Eisenberg; and the Liberatory Justice Circle, produced by me, a film activation produced by Jordan Strudwick. The festival has garner positive feedback from both our internal WPFW community, and the larger listening community who either attended or listened to our live broadcast. Many of our WPFW community performed, including Saïs Kamalidin, Proverbs Reggae Band (Ziah of Kulcha Shak), Ka'Ba Soulsinger, and DJs Abby, Lance Reynolds, Rita Burns, and Underdog. Many WPFW hands made the event lighter work! The festival was produced in collaboration with Washington Parks and People, and some the activations were held at the Josephine Butler Center.

PROGRAMMING UPDATES/CHANGES:

Rev. Mark Thompson has joined the WPFW family with a new program, *Make It Plain*, airing Mondays, 11am.

We've been in discussions with Margaret Prescod about the return of *Sojourner Truth*. Margaret took time off after reducing her commitment at KPFK to a once-a-week volunteer. She's

returning to KPFK with a co-host, and we are discussing how WPFW can once again carry the stellar program.

We are in discussions with Washington Parks and People, Brigade member Brian Burns III, and Dr. Ted Watkins about shooting and producing a health series at the Josephine Butler center to both deepen our partnership and creating consistent content to populate our YouTube channel.

Another possibility for our YouTube channel will be an on-location visual arts program hosted by Adrian Ferguson, founder of Art of Noize Gallery, entitled *In the Studio*. The program, which is just in the discussion stage, would highlight local and regional visual artists and their work, and would be shot in their studios/creation spaces, as well as cover the offerings of the galleries and museums in the DMV. Adrian was also one of our community partners, and curated a visual arts activation.

UPCOMING SPECIAL PROGRAMMING

We are working with the Hip Hop Caucus to create special programming recognizing the 20th anniversary of Hurricane Katrina on Friday, August 29.

PAST SPECIAL PROGRAMMING:

OUR ANCESTORS' WILDEST DREAMS: JUNETEENTH IN THE AGE OF ERASURE – JUNE 19

Worked with Thomas Blanton and Denise Young, we presented a Juneteenth special from 11am to noon, which convened a panel to discuss what honoring Juneteenth means in the context of the hostile political climate.

THE HOUSE THAN WANDA BUILT – JUNE 30

As we've done for over a decade, on the last day of June, WPFW commemorated Pride month with our annual Pride month programming dedicated to Beloved DC Black queer activist, Wanda Alston, a fierce advocate of housing programs for homeless and at-risk LGBTQ youth. Our LBTQIA+ programmers, the Inside Out Collective, produced *The House That Wanda Built 2025*.

From 9am until midnight, we broadcasted voices, discussed issues, and presented music honoring the life and legacy of Wanda Alston and all our LGBTQIA+ family!

FROM MISSISSIPPI TO THE CONGO: 100 YEARS OF LUMUMBA AND MEDGAR – JULY 2

While Medgar Evers and Patrice Lumumba were not personally acquainted, their lives and struggles are often commemorated together due to the parallels in their commitment to fighting for the self-determination and liberation of African people. WPFW, in partnership with Friends of the Congo, celebrated the centennial of this parallel vision with From Mississippi to the Congo: 100 Years of Lumumba and Medgar last Wednesday, noon until midnight.

HIGHER: THE POETIC GENIUS OF SEKOU SUNDIATA AND THE MUSICAL INNOVATION OF SLY STONE – JULY 4

This past Friday, 9am – 7pm, WPFW presented *Higher: The Poetic Genius of Sekou Sundiata* and the Musical Innovation of Sly Stone from 9am until 7pm. We begin at 11am with an airing of Sekou Sundiata's 51st Dream State, a multi-media meditation on empire. At 11am, our multi-faceted exploration of Sly Stone kicked off with Brother Jamil; James Funk 1pm, and Lance Reynolds at 4pm.

Miyuki Williams, Interim General Manager IGM Report July 2025

Transmitter

June 17 a rodent caused our power box to catch fire, Pepco cut power. Moe was able to put us on a generator. Later we have started "borrowing" power from WAMU. Free State electrons charged us \$6000 for the connection, and additional \$20K for the box repair, which was completed on July 2. We were able to schedule an inspection from DOB Monday July 7, we are currently waiting for Pepco to reconnect us. We have been broadcasting at low power since.

The frequency of outages are too much. Moe and Frenchy are installing a system that will alert engineers. Programmers and engineers need a system they can check in real time.

This event is not covered by insurance. Tom Chase is looking into grants we may qualify for some grants. This is a huge hit on our budget.

Jazz & Justice Festival 2025

The Jazz & Justice Festival was a hit. Washington Parks and People estimated attendance to be over 5000 through course of the day, 1000 at its fullest towards the end of the day. The feedback has been mostly positive. Giving consideration to making this an annual event. Want to thank LSB members Kamau, Dennis, Verna, Wanda and Mariah for working with us.

The Festival successfully spotlighted WPFW talent. Many Programmers participated



- Overall, June operations consistent with budget, except for \$26k emergency expenses for temporary (\$6k in June) and permanent (\$20k In July) repairs following the recent power failure at the transmitter.
- 2. A \$15,000 Diverse City grant and \$3,000 in-kind contribution from DC allowed the Jazz & Justice Festival to break-even.
- Additional, significant expenditures are needed for tower resiliency, staffing, fundraising software, and more; management is exploring additional grant opportunities to address these needs.
