UPDATED PROGRAM DIRECTOR REPORT SEPTEMBER 2025

In addition to regular PD duties, the projects listed below reflect highlights of the work:

PLEDGE DRIVE

We have begun planning for the Fall pledge drive by contemplating themes, and special programming.

TWO YEAR ANNIVERSARY OF GENOCIDE IN PALESTINE

We have begun planning special programming for the 2-year anniversary of the beginning of this iteration of the Nakba since October 7, 2023. Exact date of special details, TBD.

SOCIAL MEDIA

Continuing to work with our social media consultant to amplify WPFW's on-air programming; raise awareness about listener-supported media and why that's critical; highlight our Programmers and Staff; provide emancipatory education on the issues and music covered/presented by WPFW; cultivate new social media followers, new listeners, and new donors. Our IG account has grown exponentially and continues to increase. Many in our DMs comment on donating to the station. Spent a day in-person with our consultant creating content, and showing him how WPFW's studio worked, how programs are broadcast, etc. We also scheduled a workshop for Programmers and facilitated a meeting between Kwadjo and the rest of the paid staff, including the News team – Sue Goodwin and Noah Portner – to discuss how to utilize social media to amplify the newsletter's offerings and extend its reach.

5K ON-AIR SUPPORT

Worked with Martha Peterson to edit PSA copy to ensure message was Pacifica guideline compliant; also worked with Dr. Nick to produce PSAs and place in rotation. Suggested to Programmers that they book either Martha or some of the participating wellness facilitators on their programs to help create excitement about the event so listeners will register. Some responded with interviews of Marth and others.

PROGRAMMING UPDATES/CHANGES:

Jon Jeter, host of *Short Money*, broadcasting Thursdays, 2-3pm, has immediately resigned due to a teaching gig in ETHIOPIA!:-) We congratulate him. For the next month, we will re-broadcast some of Jon's best show, as we take time to identify the most suitable program to fill his slot; there's also the possibility of Jon providing pre-recorded programs, but only after he gets settled in Ethiopia.

In collaboration with Washington Parks and People, WPFW filmed its second installment of the WPFW Youtube program, *In the Studio*, hosted by Art of Noize gallery owner Adrian Ferguson and shot by Brigade member Brian Burns III. Egyptian artist Mona El-Bayoumi was the guest; it will be posted in October. The episode with Maurice James will remain the most recent through September https://www.youtube.com/watch?v=bOCxbp7TioQ. The next *In the Studio* taping, will feature pianist Janelle Gill. We are working on an on-air and social media marketing strategy to drive listeners to our YouTube channel, and specifically this new program about art and artists in the DMV.

Project Censored, an excellently produced program syndicated throughout the Pacifica network and beyond, is officially airing on WPFW Tuesdays, 1-2pm. The program is an extension of the work Project Censored began in 1976 celebrating independent journalism while fighting media censorship, deconstructing propaganda, and supporting a truly free press. The program focuses on "The News That Didn't Make the News." Each week, the Project Censored team conducts in depth interviews with their guests and offer hard hitting commentary and analysis on the key political, social, and economic issues of the day with an emphasis on critical media literacy. The team is quite excited to be on WPFW and will be providing pitch shows for the pledge drives. They are also willing to assist WPFW in other ways – events, fundraising, etc.

LoveSound 2025: An Evening of Soul Sisters in Support of Friends of the Congo and WPFW featuring performances by musicians and poets including Free BenJamin, Wayna, Anna Mwalagho, Ayanna Gregory, Navasha Daya, Laini Mataka, Akua Alrich, Sweet Honey In The Rock, and more. Tickets will again be \$50, including post-performance reception. All proceeds

benefit Friends of the Congo's DRC Women, Peace and Security Centre in Kinshasa, and WPFW! Last year we raised approx. \$4000+ for WPFW. By all accounts, the evening was a success, and the house was full.

PAST SPECIAL PROGRAMMING:

Friday, August 29 – From the Ninth Ward to the Airwaves: Commemorating the 20th Anniversary of Katrina. Produced in partnership with the Hip Hop Caucus, this special programming recognizing the 20th anniversary of Hurricane Katrina, and was one of the most compelling, informative, and comprehensive specials presented on the anniversary. The program centered exclusively the voices of the most impacted, and those on the ground doing the work to rebuild still.

Monday, September 1 - WPFW presented *Labor Standing in Solidarity*, a day of programming centering the concept of collective action and mutual support among workers to achieve common goals and protect their interests - turning rights into reality! We will also offer analysis of labor's role in global inequity, imperialism, and genocide.

From 9am until 3pm, hosts Julianne Malveaux, Joni Eisenberg, Elise Bryant and Chris Garlock, and Mimi Rosenberg and Ken Nash broadcast the voices of workers and those organizing throughout the labor movement, including one of the original Rosie the Riveters, Susan King, on *Malveaux!*, Labor in resistance to the occupation of DC on *To Heal DC*, and those in the labor movement standing in solidarity with Palestine on *Building Bridges*. From 3 until 8pm, we offered a sonic reflection of labor in solidarity provided by our all-women DJ collective, *Meeting in the Ladies Room!* The programming displayed boldly that workers' rights are human rights on WPFW. I engineered 8am – 3pm on Labor Day, as well.

- **Transmitter**: Post-rat repairs have been completed. Moe reports stability, though we are monitoring closely for any residual damage.

- **Studio Equipment**: New high-caliber turntables are in place; strict guidelines have been reiterated regarding stylus use. Equipment covers are on order.

Programming & Content

- Public Affairs: Programmers are staying relevant and creative. Securing great guests
- News: National News development continues with Sue and Noah; coordination with Pacifica partners remains active.
- Compliance Training: Staff continue to adjust under the consent decree; Jon Almeleh will provide further clarification Sept 9.

Fundraising & Development

- Coltrane/Charles Fund Day Drive.: Sataria will present on September 23 fundraiser.
 Current goal targets for Fall remain ambitious—we must focus on programmer accountability and listener engagement.

 Updates will be shared as agreements progress.

- Consent Decree: We remain under FCC oversight for 10 more months. Staff are reminded that ignorance or oversight will not be an acceptable defense if errors occur.
- **License Renewal**: WPFW's license is under review in 2026; vigilance in compliance is paramount.

Community Engagement & Events

- Working with LSB for 5 K walk/run
- Continued partnerships with community organizations are strengthening WPFW's visibility and relevance.
