6. Motion on KPFT Delegate Mike Lewis

Be it resolved that the PNB verify the violation of the Bylaws and order the KPFT LSB to comply with the Pacifica Foundation Bylaws <u>Article Four, Delegates, Section 8: Terms of Office, Term Limits</u> (*pasted below) and replace termed out Delegate Mike Lewis with the next runner-up from the previous election, Rodrigo Bravo because Delegate Mike Lewis has been sitting on the KPFT LSB for over <u>8 years without a 12 consecutive</u> months break.

ADDENDUM

This issue is not covered by any decision/motion the PNB made in 2022 or 2023 because Delegate Mike Lewis was termed out in March 2021.

Chronological Explanation of Violations:

KPFT LSB Delegate Nancy Saibara-Naritomi pointed out to KPFT LSB that Delegate Mike Lewis has been sitting at KPFT LSB for over <u>8 years without a 12 consecutive</u> <u>months break</u>. (I raised a Point of Order at the KPFT LSB meeting on February 8, 2023 and emailed the Facts to KPFT LSB).

The KPFT LSB chair, (<u>without any input from the LSB and without including in it any of the members who discovered the violations</u>) appointed a three (3) members Ad Hoc Committee to investigate the problem (Marianne Martinez, Sean McPherson and Lilian Care).

At the March 8, 2023 KPFT LSB meeting, the Ad Hoc Committee Chair, Marianne Martinez, gave a report (Lilian Care wasn't present at the meeting). According to the Approved Minutes of March 8, 2023 (*Minutes Approved on April 12. 2023. Attached to email*). The Ad Hoc Committee decided that Lewis was "off the LSB for the 2019 term" [without any written

report and without any proof of their findings or rebuttal of facts previously presented and pasted below (**)].

KPFT LSB's "super majority including Delegate Mike Lewis" allows no dissent and quickly mutes and drops any member who tries to speak.

(**) FACTS from the approved KPFT LSB minutes (and audios) posted on the Pacifica Foundation's website:

- 1. March 11, 2015 Mike Lewis is seated as a listener runner up to replace Ms. Melinda Iley-Dohn.
- 2. In November 2015, Mike Lewis ran as Staff member, was elected (2nd place) and served as Staff Delegate until the meeting of January 8, 2019 (giving with his presence at that controversial meeting the magic # 12 for quorum). *The posted Minutes of January 8, 2019 KPFT LSB meeting were approved on April 10, 2019.* (Attached to email).
- 3. On August 14, 2019, Mike Lewis (runner up #5 in the 2018 elections) was seated again with runner up #7 Tom Harper and runner up #6 Akua Holt to replace Staff members Joseph Davis, Vinishia Patel-Adams and Wendy Schroell. *The posted Minutes of August 14, 2019 KPFT LSB meeting were approved on January 8, 2020.* (Attached to email).
- 4. In November 2019, Mike Lewis was re-elected and is serving continuously until now. Mike Lewis was off the KPFT LSB only from February 2019 to July 2019. Obviously failing to meet the requirements of the Pacifica Foundation Bylaws:

(*) Article Four, Delegates, Section 8: Terms of Office; Term Limits

"A Delegate's term of office shall be three (3) years, beginning in December. A

Delegate may serve a maximum of two consecutive 3-year terms, and in no event
more than six (6) consecutive cumulative years without a one year (12 consecutive
months) break. If a Delegate serves as elected or alternate for an incomplete year,
those month/s of service must be counted towards the six years cumulative limit. Only
a one year (12 consecutive months) lapse as Delegate will trigger the reset of the 6
years cumulative limit."
